Chosen Sport or Activity Eligibility Criteria:

Eligibility:

- Applicant must be a Wei Wai Kum member.
- Applicant must be 18 years and under.
- An individual may apply for sponsorship to participate in a team sport or individual sport or activity.
- Parents or guardian will be expected to apply for sponsorship on behalf of all minors
- Applicant and guardian will guarantee a commitment and be ready and willing to contribute to fundraising efforts, which will be indicated in the application for funding.
- Approved applicants must commit to volunteering at (one) 1 Wei Wai Kum Nations community event for each year funded, upon the request of the Thunderbird Recreation Executive Committee (TREC).
- All applications that meet the criteria will be considered
- If a child is at an Exceptional/Gifted level in their chosen sport or activity, parents are required to meet with TREC so that they can jointly work together to plan for the child's financial requirements in the sport or activity they are excelling in.

Funding Criteria:

• All approved funding is based on available funding

- Eligible Costs Include: registration fee(s), travel and accommodation for an individual applicant or the Wei Wai Kum members of a team.
- When possible registration fees will be paid directly to the chosen sport or activity's organization
- Original receipts must be provided for all sponsorship funds from the Thunderbird Recreation Executive Committee (TREC), not providing receipts will impact your ability to access future sponsorship.
- The Thunderbird Recreation Executive Committee (TREC) will take fundraising amounts and efforts into consideration when determining the amount to be donated to both individuals and teams.
- Fundraising efforts will be used as a measure of the participant's commitment to an activity.

Applications:

- Application forms will be filled out in complete detail; incomplete applications will not be considered.
- Receipts must be provided to the Committee when seeking reimbursement applications for reimbursement without receipts will not be approved.
- Applicant must submit requests prior to monthly
 Thunderbird Recreation Executive Committee (TREC)
 meetings to allow the committee sufficient time to review.
 (Exceptions can be made in the event of short time lines when reaching a next level—Provincials, Nationals, Rep or Competitive level)

- The Committee does not guarantee the full amount of the request. The amount, circumstances and availability of funds will all be taken into consideration.
- The Committee is able to table an application and request further information prior to making a decision.

Committee Decisions:

• The decisions of the Thunderbird Recreation Executive Committee (TREC) are final, as each application is fully considered and discussed based on the eligibility of the application and corresponding with the Policies and Procedures Manual

-Individual and team fundraising is an important part of any activity and indicates personal commitment and contribution.
